Governing body regulations (academies)

- Governors are appointed/elected as follows:
 - Co-opted appointed by the governing body
 - $\circ~$ Foundation appointed by the Diocese
 - Member Appointed appointed by Members (usually in single academies)
 - Parent/Staff elected by parents/staff respectively
 - Trust Appointed appointed by the Trust board (usually in MAT academies)
- Governing bodies must have at least three governors, and at least two Parent governors for single academies (for MAT academies, either the Trust board should have at least two parents, or each local governing body should have two Parent governors).
- The term of office for any governor shall be four years, save that this time limit shall not apply to any post which is held ex officio. Parent governors may serve out their term of office when their child leaves the school, but Staff governors must resign when they leave the school.
- The governors shall, each school year, elect a Chair and a Vice-Chair from among their number, and governors who are members of staff cannot be Chair or Vice-Chair.
- The governors shall hold at least three meetings in every school year, and the quorum for a meeting of the governors, and any vote on any matter thereat, shall be any three governors, or where greater, any one third (rounded up to a whole number) of the total number of governors holding office at the date of the meeting, who are in each case present at the meeting and entitled to vote on the matters to be resolved (or two-thirds (rounded up to a whole number) if voting on the removal of a governor or the Chair).
